1: This agreement states that contractor is to engage in a home improvement act, specifically limited to description below and to supplied estimate form. All work is to be completed in agreement with local building codes. The owner is to make payment according to listed payment terms.

2: The contractor will provide all necessary tools, labor, materials, and transportation of all tools and material, and removal of excess building materials and scrap.

3: The owner will provide electrical power and running water, both within 100 feet of construction site.

4: Although every effort will be made to minimize impact on owners property, the contractor is not responsible for damage to lawns, sidewalks, or driveways due to delivery or pickup of equipment or materials: theft of materials from owner's property or delays beyond the contractor's control: fires, vandalism, flood, or any other acts of god.

5: Payment terms: The owner is to provide a deposit of 33% of the purchase price and the balance is due immediately upon completion of work. Additional smaller deposits to hold slots in schedules may apply, and larger jobs may have multi payment terms. (Please note: you will receive no further billing statements, You must make arrangements for final payment at or before work is completed.)

6: Any alterations to this contract, i.e.: Additions, deletions, or changes of any kind must be in writing and signed by both owner and contractor, and shall be treated as amendments to this contract. Such changes will require replanning and will involve additional costs.
